

Good morning, N

I am in receipt of your complaints about helicopter noise on the following dates:

- 2 December 2021 0120 and 0230 hors
- 4 December 2021 0950 0955 hours
- 21 December 2021 0030 hours
- 30 December 2021 2310, 2355 0005 hours and
- 31 December 2021 0900-0907 hours.

I am sorry to hear that you are being disturbed by noise from helicopters using the Aerodrome. Your postcode is approximately 650m from the closest hangar unfortunately, in this location, you will subject to helicopter noise.

The Aerodrome is used H24 by emergency service helicopters together with two news gathering helicopters. The noise is particularly noticeable when there is a southerly/south-westerly wind as the wind "carries the noise" (I know as I grew up in Trindles Road and, with the wind in the right direction, ground running helicopters were clearly audible).

The ground running is kept to a minimum however each helicopter operated by Air Ambulance Kent Surrey Sussex and National Police Air Service are checked at the start of each shift to check serviceability. Should a fault be found then further runs are required until it is cleared. I have attached a diagram showing the location of the helicopter operators hangars.

Approximately thirty years ago we had an opportunity to construct a grass covered earth bund at the northern end of the Aerodrome to help to deflect the noise of helicopters with engines and rotors running however planning permission was refused as the planning authorities considered t was inappropriate development in the green belt and the noise generated by fixed-wing aircraft and helicopters did not meet the threshold to consider special measures. It is for similar reasons that whenever we object to noise housing developments within our circuit areas we are told that the noise generated by our aircraft is not sufficient to refuse planning permission.

Your complaints will be recorded in my report to the Redhill Aerodrome Consultative Committee. Details of Noise Complaints, Out of Hours Movements and Consultative Committee minutes may be viewed on our website http://redhillaerodrome.com >> General information.
