Good afternoon Mr



I sorry that you are disturbed by the noise of the light aircraft operating from the Aerodrome.

As you state the area where you reside is a new development that has been built within the ATZ and adjacent to downwind leg for Runway 08/26. Redhill Aerodrome's policy is to object to all new developments within the ATZ especially those close to the established circuit pattern due to residents being subjected to noise however the planning authorities do not consider the noise levels generated by light aircraft to be sufficient to refuse planning permission.

The circuit patterns aerodingre designed to maximise the overflying of built areas however the demand for housing is slowly eroding these spaces. Developments with the ATZ should be aware of the published circuit patterns.

The main activity at Redhill is flight training in fixed-wing and helicopters; to that end we operate a standard rectangular circuit pattern. I have attached a diagram of the 08/26 circuits with your location marked on, unfortunately at this location you will be subjected to aircraft noise whenever the 08/26 circuit is active. The circuit altitude is 1200ft which is the maximum we can utilise with the Gatwick CTA overhead.

Apologies for the delay in responding to your complaint however I was waiting to collate all the information.

I am sorry that you were disturbed by their noise of the emergency service helicopters operating from the Aerodrome. I have attached details from our movement log for the helicopters operated by the Air Ambulance Kent Surrey Sussex and the National Police Air Service, please not the times are recorded in UTC (GMT) therefore one hour needs to be added for BST. The wind was easterly on on both nights this would cause any helicopters to make their approach from the west; adjacent to your location. Both the operators are well aware of the disturbance that can be caused to local residents, especially in the early hours, and make great efforts to minimise it.

Not one to usually moan about noise from the aerodrome as it's never preciously bothered me but this last 2 nights I have been woken from sleep due to a helicopter nouse, yesterday after 22:30 and tonight nearer 23:10.

I live on Royal Earlswood Park and it's never usually that loud unless a helicopter is landing at the hospital. This time, both nights it sounded like it was directly over head and then flew around the area for quite a while (I can still hear it now!).

If this was a police helicopter then I understand that really can't be helped and will presume it's just unfortunate to happen two nights in a row?

If it's not an emergency service then I really hope this won't be happening on and on going basis at night, it's an awful racket (unlike I have ever heard from the aerodrome before in the 5 years I have lived here) and woke both my husband and I from a deep sleep.
